Q1 2021

VC Activity

The total for Q1 2021 is **€250m** v **€229m** for Q1 2020 up 8.9 %.

Deals of less than €1m recovered up 53% in value on last year **€13m** v **€8m** and in volume up from 22 deals in number to 34 or 55% increase.

Lifesciences dominated again accounting for 52% funds raised, driven by an **€89m** round for Mainstay Medical.

Number of deals in the quarter up 65% on last year, with 74 funding rounds in the quarter versus 48 last year.

Seed funding rounds up 65% from **€22m** to **€37m**.
