- 20 Partners plus      Annual Subs €3,300

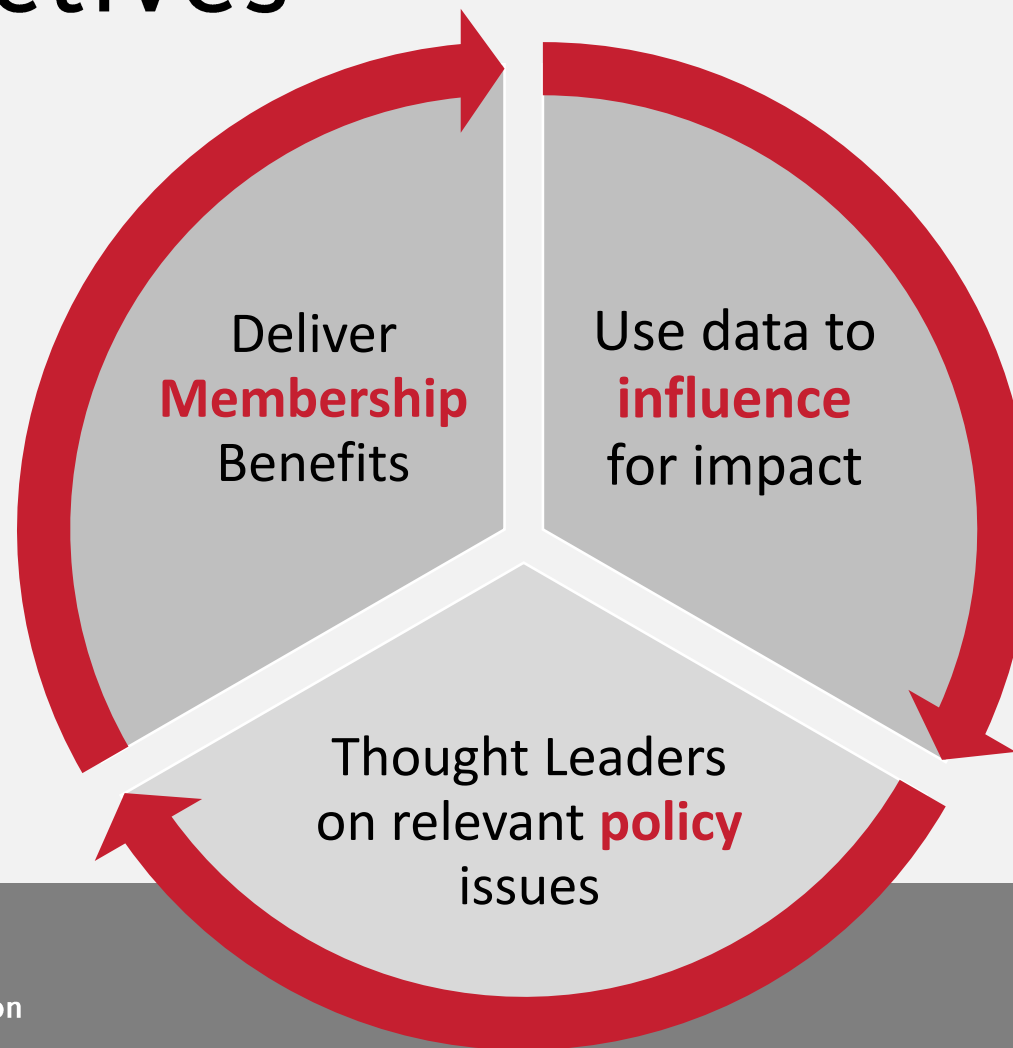
# IVCA Strategy

# 1. Use our data to **influence** for impact

Position the industry and members as key contributors to business growth in Ireland and the EU

## Venture Pulse

- 1.1** Produce high quality Venture Pulse **quarterly data**.
- 1.2** Garner strong **media coverage** for data.
- 1.3** Maximise the data reach by executing a **content plan** to amplify and atomise content on social and other channels.

## Impact Index

- 1.4** Develop an **annual impact index** which details economic impact measures within portfolio companies such as jobs created, patents registered as well as ESG metrics.
- 1.5** Work with **CFO group sub-committee** to define metrics.
- 1.6** Publish annually, secure coverage & stakeholder **awareness**.

## 2. Thought Leaders on Policy

Position the IVCA as a respected commentator within the industry and the wider business and policy environment in Ireland and secure policies favourable to the funding landscape, including a broader and more diverse LP pool.

- 2.1** Use IVCA data as a building block to develop insights, policy requests and additional content e.g. white papers, opinion pieces, and campaigns advocating for these policy changes and developments.
